Continuous Coverage Unwind

- Consolidated Appropriations Act, 2023
- Continuous Coverage Unwind Status

Consolidated Appropriations Act, 2023

Congress passed the Consolidated Appropriations Act, 2023 (CAA) that included a number of health policy provisions. The law:

- Delinks the Medicaid continuous coverage policy from the end of the COVID-19 public health emergency
- Allows States to begin eligibility redeterminations starting in April 2023
- Provides a phase-down of the enhanced federal Medicaid funding throughout 2023 with certain conditions
- Requires States to provide the Centers for Medicare & Medicaid Services (CMS)
 with specific data regarding unwinding activities

Continuous Coverage Unwind Status

Preparing for the Continuous Coverage Unwind

- Reviewing the CAA and the initial CMS guidance for impacts
- DHS is working with counties, tribes, MNsure, MNIT and others to plan for the resumption of public program renewals and other eligibility processes
- MNsure has worked with GetInsured to develop system support for consumers who will be enrolling in QHP coverage after loss of public program coverage

Returning to normal operations: Challenges and Risks

- CMS issued an informational bulletin on January 5, 2023, and is working on additional guidance for States on key unwinding provisions
- Unprecedented expected volume of renewals
- Limited resource capacity for DHS, Counties, Tribal Nations, MNsure and MNIT

METS SGG Oversight of Maintenance & Operations Costs

METS ESC provided the following direction to the METS SGG:

- Better understanding of the METS Ops budget
- Expand governance role to track total funding and expenditures
- Make recommendations to METS ESC regarding METS maintenance and operations costs
- Business Partners to collectively make decisions and/or recommendations that impact the METS maintenance and operations budget
