## **CEO Report**


- Two March deadlines
  - March 15 for April coverage
  - March 31 to meet the insurance requirement and avoid penalty
    - Coverage effective for May
  - No QHP enrollment until November 15 fall open enrollment begins
    - Exception of life events
  - Enrollment in Medical Assistance, MinnesotaCare and SHOP run year-round

## **CEO Report: Enrollment**

- Enrollment as of March 11:
  - 118,629 total enrollments
    - 61,643 Medical Assistance
    - 33,362 QHP
    - 23,624 MinnesotaCare



## **Enrollment in Process**




## **CEO Report: Call Center**

## Call Center – Average Wait Time/ASA




## Call Center SLA – Abandon Rate/SLA

# 2015 Budget

- Preliminary budget for calendar year 2015
- MNsure is required to report a board approved, 2015 budget to the Legislature by March 15
- The proposed budget is smart and balanced; it reflects recent experience for costs and revenues

- It is consumer-focused we are investing in areas to help Minnesotans get health care coverage
- The final 2015 budget will be presented for Board approval in October
