





Communicating federal changes and their impact on Medical Assistance enrollees



A new law
brings major
changes to
some Medicaid
enrollees.

- ▶ A **new federal law** causes major changes to Minnesota's Medicaid program, called Medical Assistance.
- ▶ **Nothing has changed yet.** The first changes happen in October 2026, and the majority won't happen until January 2027.

Key message #1



Rely on DHS to
keep you
informed.

- ▶ **DHS will serve as your trusted guide to prepare.**
 - ▶ The law passed recently, so DHS does not have all the answers yet. However, the State of Minnesota has committed to helping you understand the added challenges and what you need to do to maintain health care coverage.
- ▶ **Use DHS resources to stay informed.**

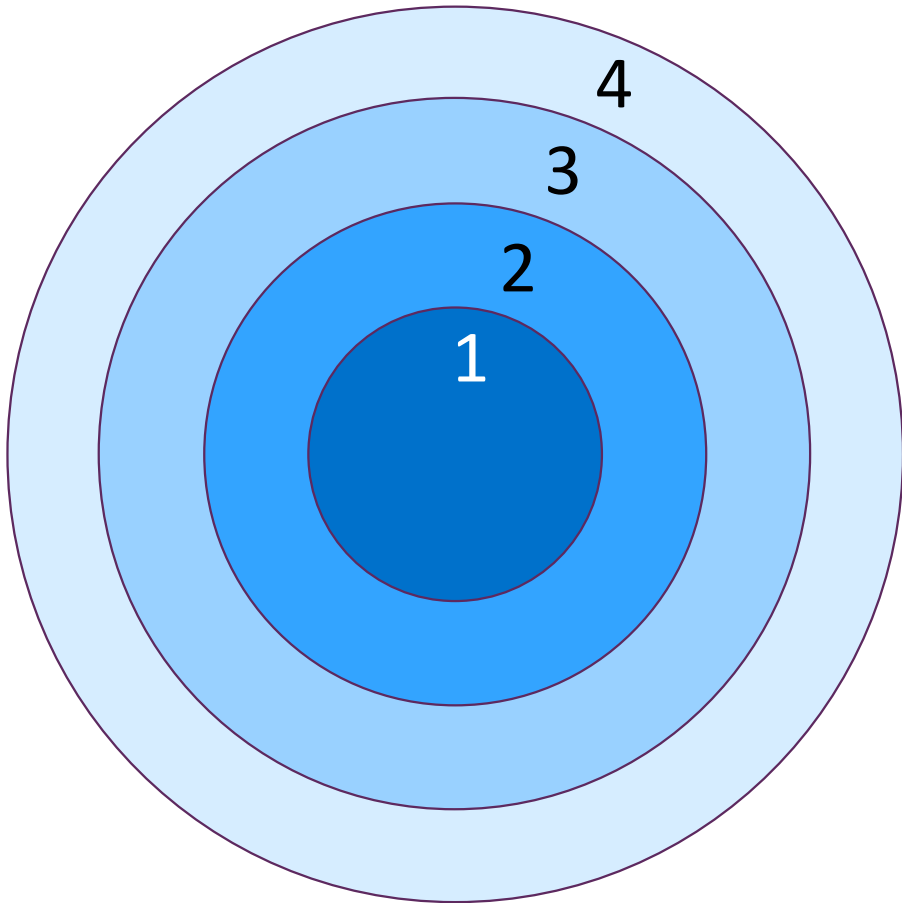


Medicaid matters.

1. ~1.3 million Medical Assistance and MinnesotaCare enrollees
2. Eligibility workers at DHS, Tribes, counties
3. Managed care health plans
4. Navigators, providers, community groups, advocacy organizations

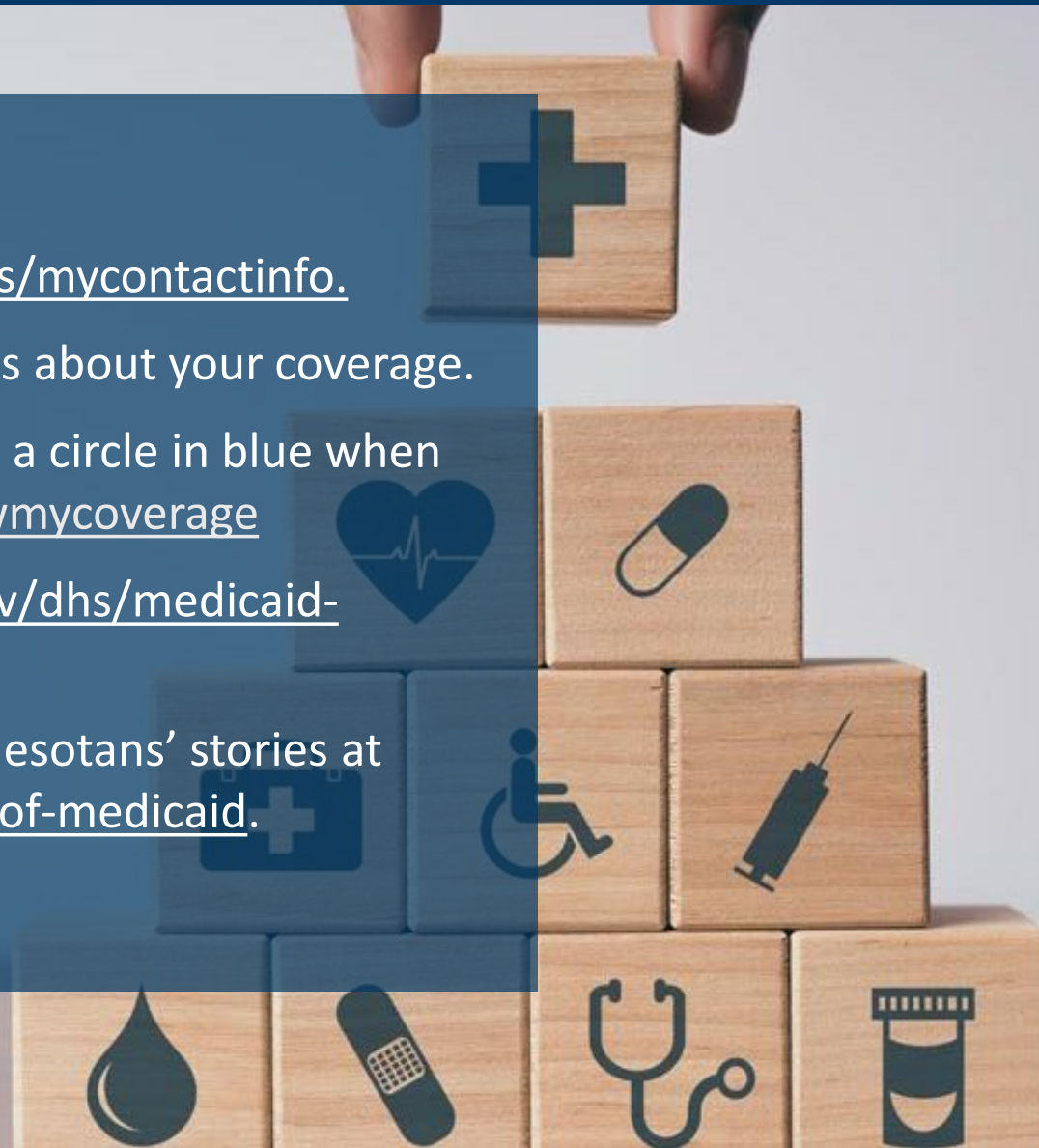
Communications strategies

- ▶ Drive enrollees to a new webpage: mn.gov/dhs/federalchanges
- ▶ Give as much advance notice as possible
- ▶ Write in plain language, 7th-grade reading level
- ▶ Translate into Hmong, Somali, Spanish
- ▶ Bridge terminology gap, e.g., Medicaid = Medical Assistance
- ▶ Use a broad approach with multiple tactics
- ▶ Follow lessons from the unwinding
- ▶ Seek partner, community input
- ▶ Amplify messages using partner toolkit materials
- ▶ Use culturally relevant imagery

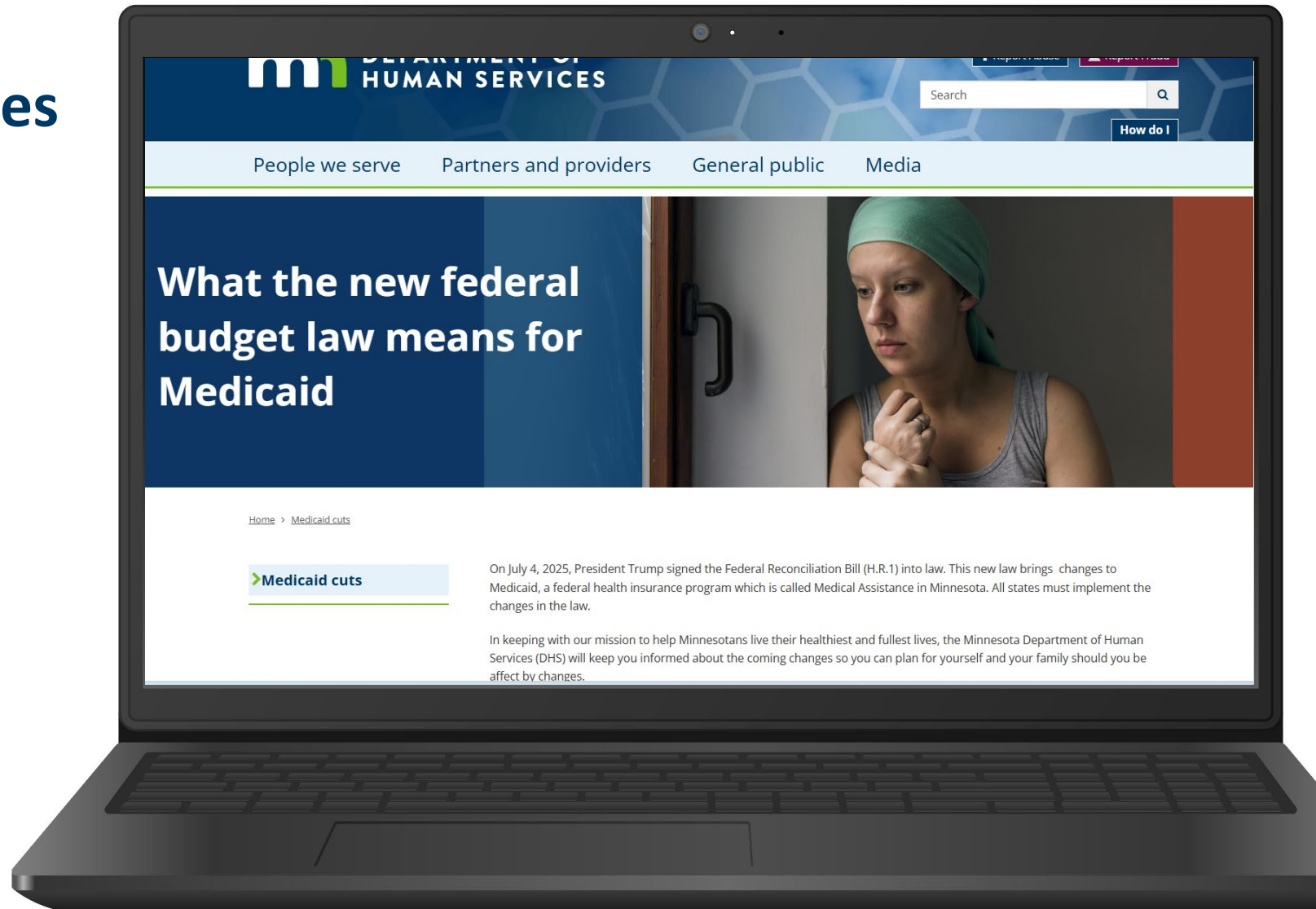
