

Navigator Network Grants

Nearly \$3 million; nine grants will fund 44 organizations

Focus

Navigator Network grants focus on building statewide access to enrollment assistance and sustaining a network of navigator organizations working closely with MNsure on strategies to reach, enroll and renew consumers in health coverage.

Grantees in this area have:

- Skilled navigators able to assist consumers who require assistance with all aspects of the application and enrollment process.
- Capacity to assist consumers with post-application issues to ensure they successfully enroll in appropriate coverage.
- Capacity to offer year-round enrollment assistance in the geographic region defined by the applicant.
- Established relationships with populations facing barriers to enrollment.
- A long-term organizational commitment to providing navigator services, including outreach, education and enrollment.
- Capacity to mentor and share resources with other navigator organizations.
- Capacity to collaborate with MNsure on outreach and enrollment strategies, including partnering with broker enrollment centers and receiving direct referrals for application assistance from MNsure.

Navigator Enrollment Grants

\$1 million; 14 grants will fund 18 organizations

Focus

Navigator Enrollment grants support navigator enrollment capacity (navigator staff) within organizations that can demonstrate an ability to reach populations with high levels of uninsurance.

Grantees in this area have:

- Skilled navigators able to assist consumers who require assistance with all aspects of the application and enrollment process.
- Capacity to assist consumers with post-application issues to ensure they successfully enroll in appropriate coverage.
- Year-round enrollment assistance, but increased activity during the annual open enrollment period.
- Strong connections to the identified population the grantee is serving and existing outreach capacity.



African Community Senior Services

- Utilize the Community Health Worker (CHW) model to confront and dismantle the barriers immigrant communities face as they pursue an optimal state of health and well-being by accessing the healthcare system.
- Target Latinos and immigrants living in both urban and rural areas. The urban areas include the Twin Cities and the surrounding counties and the rural areas include areas in Southern Minnesota with high Latino population.
- Leverage existing partnerships and build new relationships to enhance referral network in rural areas.



Face to Face Health and Counseling Service

- Work one-on-one with uninsured youth in an effort to successfully educate and enroll them in MNsure.

- Partner with Oasis for Youth, Minnesota Displaced Workers, and the Minnesota Internship Center Charter School to enroll homeless youth, workers experiencing loss of health insurance coverage, and populations of color.
- Multiple clinics located throughout the state to serve many different diverse populations that face barriers to health care in Minnesota.
