

Health Insurance Options for DACA Recipients



Good News: You May Be Eligible for Lower-Cost Insurance

As of Nov. 1, 2024, DACA recipients may be eligible for either:

- a qualified health plan (private health insurance), with or without tax credits
- MinnesotaCare (a public health care program)



What is covered?

Both MinnesotaCare and qualified health plans cover these benefits and more:

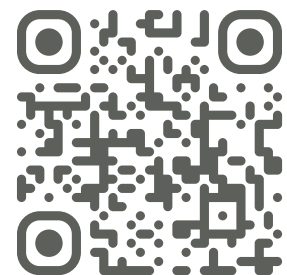
- Doctor visits
- Prescribed medications
- Vaccines
- Mental health care
- Substance use disorder care
- Maternity and newborn care
- Emergency services
- Free preventive care

What am I eligible for?

Eligibility is based on your household size and income.

People in Household	MinnesotaCare Annual income	Qualified Health Plans Annual income
1	up to \$30,120	more than \$30,120
2	up to \$40,880	more than \$40,880
3	up to \$51,640	more than \$51,640
4	up to \$62,400	more than \$62,400

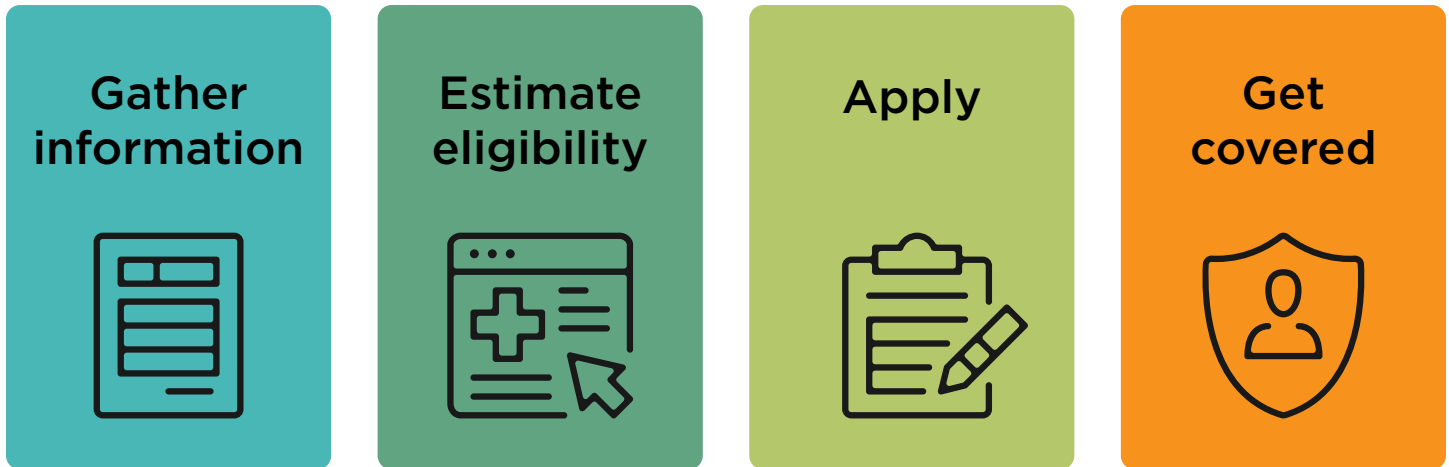

How do I sign up?

If you are a DACA recipient applying for the first time, here are the basic steps:



If you've applied before: Call the MNSure Contact Center at 651-539-2099 (855-366-7873 outside the Twin Cities).

Get Free Help From an Expert

MNSure-certified brokers are health plan experts who can answer your questions and give advice — at no cost to you. Brokers can help you choose the right plan, if you're eligible for a qualified health plan.

Navigators provide free health insurance application and enrollment help at local, trusted community organizations. Navigators can help you sign up for MinnesotaCare if you're eligible.

Get Help in Your Preferred Language

Can my family get health insurance, too?

It depends! The best way to find out what your family qualifies for is to fill out an application.

Do I need a Social Security number?

If you are applying for yourself:

- If you have a Social Security number, you must provide it.
- If you do not have a Social Security number, **you should still apply**. You may be eligible for a qualified health plan or MinnesotaCare.

You do not need a Social Security number if you are applying for someone else.
