## HIAC SHOP Recommendation

#### **Issue Statement**


- No medical carriers are offering small group coverage through MNsure
  - July 2017, BCBS announcement
- Small group coverage is still available "off-exchange"
- What should MNsure's response be to this change?

#### Background

- SHOP created by the ACA to provider a marketplace for small employers (2-50 FTEs) to cover employees
- SHOP enrollment in Minnesota is below projections.
  - Appx. 2,000 actual in 2016 vs. projected 155,000
- SHOP enrollment in most of the US is below projections.
  - Appx. 233,000 actual in 2016 vs. projected 4 million



## SHOP Recommendation to MNsure Board

- Given there is no MEDICAL carrier participation in SHOP, MNsure should do the minimum necessary to not violate and satisfy federal regulations or align with the federally regulated open enrollment requirements for SHOP.
- Additionally, MNsure should redirect whatever SHOP resources to the individual market product support.
