## **Meeting Topics**

#### Welcome

The meeting was called to order by Chair Stephanie Stoffel at 1:08 p.m. MNsure's chief legal counsel, Dave Rowley, conducted a roll call and there was a quorum with six board members present at the start of the meeting.

### **CEO Report and Open Enrollment Update**

#### Libby Caulum, Chief Executive Officer

MNsure's open enrollment (OE) period for plan year 2024 ends January 15, 2024. A comprehensive update on OE sign-up activity will be provided at the March board meeting.

Sign-up data for 2024 coverage shown reflects Minnesota Eligibility Technology System (METS) activity from November 1, 2023, through December 31, 2023:

- 137,285 qualified health plan (QHP) sign-ups
- 26,315 Medical Assistance (MA) applications
- 3,677 MinnesotaCare applications

Roughly 58% of enrolled households are receiving advanced premium tax credits (APTC) that lower the cost of monthly premiums. The average APTC is about \$538 per household.

At the end of December 2023, MNsure had just under 111,000 QHP enrollees, over 8,000 more than we had at the end of 2022. MNsure typically sees a slight decrease in enrollments throughout the year; month-to-month enrollment maintenance or growth contrasts with the typical trends and may be attributed to the Medicaid unwinding. MNsure is tracking above forecasts for premium withhold revenue.

The MNsure Contact Center is continuing to see higher call volumes, with an increase of about 53% during the first eight weeks of open enrollment compared to the same time period in 2022.

The Contact Center will be closed over the Martin Luther King, Jr. holiday weekend, but consumers can continue to enroll through MNsure.org until 11:59 p.m. on Monday, January 15, 2024. MNsure has put a process in place to assist anyone who experiences issues enrolling over the weekend.

#### Continuous Coverage Unwinding

Coverage transition data as of January 8, 2024:

- 29,622 cumulative total QHP-eligible
- 10,575 cumulative total qualifying life events reported
- 8,226 QHP selections

To date, nearly 30% of the total newly QHP-eligible population have signed up for coverage through MNsure and selected a plan. Of this group, over 90% selected coverage for 2024 or coverage for both 2023 *and* 2024, indicating that many are successfully finding QHPs that meet their needs and are planning for 2024 coverage through MNsure.

### 2023 Goals and Measurement: Quarter 4 Update

### IT and Executive Steering Committee Update

Processes and procedures in place have ensured stability and smooth operations through the open enrollment period to date. The QHP Eligibility System Transition project continues in the planning stage. The project team is working through design needs and when GetInsured will become the system responsible for determining QHP eligibility. There are no changes to the METS FFY 2024 roadmap that affect MNsure. The Curam upgrade is on track to deploy on June 23, 2024. Mr. Wright also introduced the new MNIT CBTO, George McNulty, to the board.
